Vice-Chancellor's Report to Council

May 2022

Introduction

Following the completion of the external audit, and with the final approval from Council, the UC Annual report for 2021 was released online. Hard copies were printed, hosted a series of hui for staff with Keith Longden the Executive Director Planning, Finance and Digital Services. We gave staff the opportunity to find out more about the financial position of UC.

Highlights of the report include that UC returned a \$5.7 million surplus on core activities thanks to improved domestic student numbers, increased research revenue and vigilant cost management.
